## County Refuses to Make Movement in Mediation Forcing Bargaining Team to Fact Finding

County refuses to make movement during mediation—Bargaining team takes proactive move and files for fact finding.

The County continues its delay tactics by refusing to make any movement in mediation sessions. At this point, the County either doesn't know what to do or doesn't care about their employees. Their stonewalling on these issues will not stop our fight for the return of part of the illegally imposed 9 percent pay cut and other well-earned benefits. Our bargaining team has taken the initiative and informed the County that we are moving ahead to fact finding.

Fact Finding will force the County to open up their books to a panel and be honest about their financial situation. Our bargaining team is energized and ready to fight until we get a fair resolution while the County is running out of places to hide. Standing strong together, we will win a contract that respects us, the work we do and the vital services we provide to the citizens of Fresno County every day.

Our attorneys are working with the fact finder and the county's attorneys to work out the schedule and details so they can begin the process. The county will have to open their books, and prove that their imposed cuts were necessary, and remain to be as their

position in bargaining has been to remain status quo. It is our intent that the fact finding will prove that the county does not have as serious a budget crisis as they have tried to lead us to believe.



# MEASURE "B" PASSES!

Measure B passed once again on November 6, 2012 which will ensure in maintaining services and extended hours to the residents of Fresno County.

Measure B is a 1/8<sup>th</sup> cent sales tax that has provided 53% of the Fresno County Libraries income since 1998. Measure B was due to expire in March of 2012, but since the voters once again voted in favor of funding the libraries it will continue for another 16 years.

This will continue to make the libraries of Fresno County available to the residents and

to future generations. SEIU Local 521 members were instrumental in making this election a win by spreading the word, posting yard signs, phone banking, and mailing literature about the measure to ALL SEIU Local 521 members about the importance of this issue.

## 2013 Election of Localwide Officers, Executive Board Delegates, Trustees and Bylaws Amendments

From January 5-23, 2013, a vote will be held to elect SEIU Local 521's Localwide Officers, Executive Board Delegates and Trustees for the 2013-2016 term of office, and to amend the Local 521 Bylaws. (There will be no change to the dues structure)

Nominations Open: The nomination period begins on Thursday, November 1, 2012, and closes on Friday, November 30, 2012, at 5:00 p.m. All original nomination petitions, with original signatures only, may be sent by U.S. Mail (delivery confirmation service recommended) and postmarked by Wednesday, November 21, 2012, or may be delivered in person to one of the local union offices listed by 5:00pm Friday, November 30, 2012. Nomination forms may not be scanned, e-mailed or faxed. It is the candidate's responsibility to meet the deadline. Any nomination petitions delivered by hand after 5:00 p.m., Friday, November 30, 2012, will not be considered.



**Nomination Petitions:** Petition forms are available for download from <a href="www.seiu521.org">www.seiu521.org</a>. They may also be picked up at your local union office or from your worksite organizer. Nomination petitions require the signatures of a total of 25 members in good standing eligible to vote for the office nominated. Signatures may be collected on more than one form. A member may nominate her/himself and sign her/his own petition.

**Nomination Meeting:** A nomination meeting is scheduled for **5:30 p.m., Thursday, November 15, 2012**, via video conference at our San Jose, Fresno, Salinas, Bakersfield and Visalia offices. At this meeting, a nomination and the required second may be made by members in good standing eligible to vote for the office nominated.

Acceptance of Nomination: A candidate who has been properly nominated must submit the official Acceptance of Nomination approved by the Local 521 Election Committee no later than 5:00 p.m., Friday, December 7, 2012, according to election rules, in order to have her/his name placed on the ballot. The form is available at Local 521 offices or on www.seiu521.org.

Candidate Statements and photos: Statements and photos for the Candidate Booklet must be e-mailed to <u>elections@seiu521.org</u> by 3:00pm Friday, December 14, 2012. Statements for the booklet must be no more than 75 words. You may also submit a 500-word statement to be placed on the Local 521 website. Statements are printed as-is and will not be corrected for accuracy, spelling or grammar.
