Frequently Asked Questions

What are bylaws?

Bylaws are the set of rules and guidelines that members create and adopt to govern their chapter and union.

Do Monterey County Chapters already have bylaws?

Yes. Right now there is one set of bylaws for Units F, J & H. And a separate set of bylaws for Unit K and Unit R.

Why are we unifying our bylaws?

To be in accordance with our "One Employer, One Chapter" vision that our member delegates set forth at our union convention in November 2009. Member delegates voted to strengthen our chapters by unifying our bylaws in places where we had different chapters with the same employer. Since Monterey County has different chapters (F, J, H, K and R) with the same employer (Monterey County), we must now unify our bylaws to become one stronger, unified chapter.

What have we done so far?

Monterey County members formed a Bylaws Committee in November 2010 and collected bylaws from several other chapters in 521 who have already unified. They studied and reviewed those bylaws and our current bylaws to look for improvements. After many meetings covering 15 months they drafted our unifying bylaws, which were approved by our 521 Executive Board. They will now be voted on by the membership.

What's the benefit of unifying our bylaws?

United we stand. Divided we fall. With all the attacks on pensions, health care and jobs, it's more critical than ever that we're united. We will be stronger together as one unified chapter.

What are we voting on?

Monterey County members must vote on whether to approve the draft bylaws, not on whether we will unify our chapters. That was already decided by our members delegates at our union convention.
