• Term: 2 Year Agreement (October 13, 2014 – October 24, 2016)

• Salary:

- o 2% salary increase for all classifications effective Oct. 13, 2014
- o 3% salary increase for all classifications effective July 6, 2015
- Reopeners:
 - Employee Grievance Resolution Procedure and Form
 - o Meet and Confer Requirements (Article)
- Other cleanup contract language.

• Pending ULPCs:

Contingent upon approval by the Fresno County Board of Supervisors of the six respective tentative agreements and corresponding successor Memorandum of Understanding effective October 24, 2014 through October 24, 2016, SEIU Local 521 (SEIU) agrees to do all of the following within one week of the Board's approval:

1. Withdraw, with prejudice, all active Unfair labor Practice Charges (ULPCs) currently filed with the public Employment Relations Board (PERB) against the County of Fresno (County)

The Choice is clear, vote for a 5% pay increase now or wait for at least 3 more years to see if PERB rules in our favor. During those 3 years all members will continue to suffer a 9% pay cut with no guarantee of back pay.

PERB has never been the right way to get our money back, it was a leverage tool to force the County back to the table and get our members money. It worked!
